Transformation of banking from brick

banking to click banking made a paradigm shift in the trends of the banking in the 21st century. As per the report of IAMAI (Internet and Mobile Association of India), India is estimated to have 370 million mobile internet users by June, 2016. The rapid increase in the



number of mobile Internet users in the country increases the number of digital banking users. Many private sector and public sector banks already launched their mobile banking apps. These mobile apps will help the people to do their banking transactions even from the remote areas of the country where there are no normal banking services available. Mobile banking is a means to increase the financial inclusion in

the country. Some banks have developed two types of mobile apps- One will work via Internet and other will work without Internet through missed call, sms, app messaging, etc. This will help to extend banking services in the very remote areas of the country. Many banks also launched mobile wallets. Mobile wallet is actually a virtual wallet which is the substitute of the physical wallet which we carry every time. It will help us for making payments, storing credit cards or debit cards, loyalty cards, coupons, ticket etc. Instead of making payments through physical cash it will help us to make the payment through digital cash. It is secured through password / Pin / finger print. It reduces the chance of frauds as it is very difficult to steal or duplicate than physical cash or cards. Manju Agarwal, Deputy Managing Director, State Bank of India said that in the next 5 years, mobile will be the new bank and digital payments/acceptance system will move to micro enterprises like Kirana shops, coffee shops, etc. Some banks have already made a tie up with the different vendors for hotel booking, airlines ticket booking etc.

In order to book the tickets, we need give our credit card or debit card details in the vendor websites.



With the help of the mobile app of the bank we can directly buy tickets or book hotels.

Digitization of payment services will help the bank to reduce the volume of cash transactions in the bank. It will also help to reduce the costs and to prevent the growth of counter fake currencies. As per the report published by RBI, there are

total (approx.) 450 crores of counter fake currencies available in India and it is a threat in path of the economic development of the country. Digitization of banking will reduce cash transaction which in turn will stop the growth of counter fake currencies in the country. Digitization of banking is a step towards the making Digital India, an initiative by the governments for making India digital but at the same time it is also the responsibility of the bankers to educate the customers about digital banking and

its benefits. So that, we can achieve a special milestone in the digital world.



For this project, the class was divided into eight groups and was assigned different tasks based on the text "Great Expectations" by the

Victorian novelist, Charles Dickens.
